PRESIDENT'S MESSAGE

Dear Members,

The last two years dominated mainly by the pandemic have gone by very quickly. Due to the slowing down in our income streams we could not undertake many development and construction activities at the club, which we would have in an otherwise normal situation.

Now that we are almost moving out of the pandemic phase, we have seen some positivity in terms of increase in the club revenues. The Managing Committee also intends to renovate the gym and have Solar Power Grid.

Finally, I would like to thank the staff of B. P. S. for their whole hearted support during last one year.

Minutes of the Annual General Body Meeting held on Sunday, 26th September 2021

The Chairperson of the General Body Mr. Audhut Kare called the meeting to order at 9.30 a.m.. As there was no quorum at the appointed time, it was adjourned by half an hour to resume at 10.a.m.

In all, 22 members attended the AGM

1. Welcome by the Chairperson

The Chairperson Mr. Audhut Kare welcomed all the members present and requested them to switch off mobiles or keep them on silent mode. He read out the names of the following members who had passed away during the year:-

After that, he requested all the members to observe a minute of silence in memory of the departed members as mark of respect and then took up the main Agenda of the meeting.

2. **President's Address**

The President Mr. Santosh George thanked all members for providing him the opportunity to continue as the Club's President for the new term 2020-2023. He informed that there was a deficit of Rs. 32 lakh this year due to the Pandemic effects. Despite this, the club has managed to achieve some targets.

He informed that the work of the Synthetic Tennis Courts was completed in the month of November 2020 with the total cost of Rs. 60 Lakhs including GST and was inaugurated by Hon. Deputy CM of Goa Shri Manohar (Babu) Azgaonkar along with the Leader of Opposition Shri. Digamber Kamat in presence of eminent sports personalities and some senior club members on 25th November 2020. The Govt of Goa had proposed Rs. 20 lakhs as grants for this project out of which Rs. 15 lakhs were received till date. The club also renovated the BPS Garden Restaurant. The tender for running the restaurant was bagged by LEDA's chain of Restaurant after a competitive bidding process. The Club members could now enjoy a 15 % discount on their bill. To support government, the club provided the BPS hall facilities to be used as a Covid -19 vaccination center for the month of Jun 2021.

The President also informed that in coming financial year, the club intends to put up a proposal for Swimming Pool and Gymnasium, for which the Managing Committee had appointed Arch. Ankit Prabhudesai to prepare the plans, as soon as plans were prepared and approved by SGPDA and Margao Municipality, an Extra Ordinary General Body meeting will be called to take approval from members. He hoped to complete the tendering process within 3 to 4 months.

The President once again thanked and requested all the members to continue their support for remaining two years.

3. To read and confirm the minutes of the last Annual General Body meeting. The Chairperson requested Secretary Mr. Yogiraj Kamat to read out the minutes of the last Annual General Body meeting, held on 27th September 2020. The Secretary readout the minutes. As there were no points to discuss on the minutes, the minutes were confirmed. Proposed by Mr. Shashank Shirwaikar and Seconded by Mr. Justo D'Costa

- 4. Action Taken Report on the minutes of the last General Body Meeting. The Secretary Mr. Yogiraj Kamat readout the action Taken Report on the minutes of the last General Body meeting. As there were no points to discuss on the Action Taken report, the Report was confirmed. Proposed by Mr. Siddhartha Carvalho and Seconded by Mr. Franksy Da Costa.
- 5. To receive and adopt the audited statement of account for the year 2020-2021 The Chairperson Mr. Audhut Kare informed that the accounts were already printed in the booklet and circulated among the members and asked if any members have any queries regarding the accounts. As there were no queries from members, the accounts were then confirmed. Proposed by Mr. Amrutlal Doshy and Seconded by Mr. Raja Dayal.

To appoint auditors for the year 2021-22.

The Treasurer Mr. Prasad Chitnis proposed Ganesh Daivajna & Co. to continue as the Auditors for the financial year 2021-22 with the same remuneration of Rs.38,000/-. The General Body unanimously agreed. Proposed by Mr. Luis Silveira and Seconded by Mr. Victor R. Rebello.

To approved Budget for the year 2021-22.

The Chairperson Mr. Audhut Kare requested members to go through the Budget prepared by Treasurer Mr. Prasad Chitnis and asked members if they had any queries on budget.

The Treasurer Mr. Prasad Chitnis informed that the President Mr. Santosh George has taken initiative and working on with the Arch. Ankit Prabhudessai for construction of Swimming Pool, Steam Bath, Sauna, Jacuzzi and other related infrastructure. He informed that the plans were in the final stage and that a sum of Rs. 40 lakhs has been allocated during current financial year for this project.

He further informed that during FY 2020-21, 17 new life members were added. He proposed to add another 20-25 new life members during the next financial year. He informed that the Sports Authority of Goa, had sanctioned a grant of Rs.20lakhs for the synthetic tennis court, out of which 10 lakhs were disbursed during FY 2020 -2021. He informed that further 5 Lakhs were disbursed during the previous week and expected to receive the balance 5 lakhs within next few months.

As there were no queries from the members to discuss on the budget, the same was then confirmed. Proposed by Mr. Raja Dayal and Seconded by Mr. Ryan Cardozo

To Consider any other subject with the permission of Chair.

The Chairperson Mr. Audhut Kare informed that no letters from members have been received to discuss in the AGM. Since the live AGM meeting was held after 1 year due to COVID members were allowed to ask a few questions to the Managing Committee.

- 1. Mr. Raja Dayal thanked President Santosh George and the Managing Committee for providing world class tennis courts for the members and hoped that the club will produce national level tennis players in future.
- 2. Mr. Victor R. Rebello informed that he has noticed that the upper portion of the Club is always been well maintained but not the lower ground. He suggested to take up this issue and also provide cover between upper and lower ground. He also informed that he has not received any mail or copy of report on email ID from
 - The President Mr. Santosh George informed him that the lower ground are being cleared and put back to use, as the COVID pandemic was coming down. Regarding the Annual Report, the Managing Committee had decided to email or WhatsApp the Annual report and not to print this time, to avoid printing cost which was around Rupees 70 to 80 thousand. He assured Mr. Victor that he will look into the matter of not receiving email and will direct office to update all members records.
- 3. Mr. Glen Elroy Antao inquired whether there were any plans to organize festivals and sports activities. The President replied to him that it all depends on the Covid

The Vice Chairperson Mr. Manguirish Kunde gave vote of thanks and the Chairperson Mr. Audhut Kare once again thanked all members and adjourned the meeting at 11.20
